



## **Terms and Conditions Regarding Use of Microsoft Software**

This document concerns your use of Microsoft software, which includes computer software provided to you by Run IT Solutions Limited as described below, and may include associated media, printed materials, and "online" or electronic documentation (individually and collectively "SOFTWARE PRODUCTS"). Run IT Solutions Limited does not own the SOFTWARE PRODUCTS and the use thereof is subject to certain rights and limitations of which Run IT Solutions Limited needs to inform you. Your right to use the SOFTWARE PRODUCTS is subject to your agreement with Run IT Solutions Limited, and to your understanding of, compliance with, and consent to the following terms and conditions, which Run IT Solutions Limited does not have authority to vary, alter or amend.

### **Definitions**

**"Client Software"** means software that allows a Device to access or utilize the services or functionality provided by the Server Software.

**"Device"** means each of a computer, workstation, terminal, handheld PC, pager, telephone, personal digital assistant, "smart phone," or other electronic device.

**"Server Software"** means software that provides services or functionality on a computer acting as a server.

**"Redistribution Software"** means the software described in Paragraph 4 ("Use of Redistribution Software") below.

### **Ownership of Software Products**

The SOFTWARE PRODUCTS are licensed to Run IT Solutions Limited from an affiliate of the Microsoft Corporation ("Microsoft"). All title and intellectual property rights in and to the SOFTWARE PRODUCTS (and the constituent elements thereof, including but not limited to any images, photographs, animations, video, audio, music, text, and "applets" incorporated into the SOFTWARE PRODUCTS) are owned by Microsoft or its suppliers. The SOFTWARE PRODUCTS are protected by copyright laws and international copyright treaties, as well as other intellectual property laws and treaties. Your possession, access, or use of the SOFTWARE PRODUCTS does not transfer any ownership of the SOFTWARE PRODUCTS or any intellectual property rights to you.

### **Use of Client Software**

### **Use of Redistribution Software**

In connection with the services provided to you by Run IT Solutions Limited, you may have access to certain "sample," "redistributable" and/or software development ("SDK") software code and tools (individually and collectively "Redistribution Software"). YOU MAY NOT USE, MODIFY, COPY, AND/OR DISTRIBUTE ANY REDISTRIBUTION SOFTWARE UNLESS YOU EXPRESSLY AGREE TO AND COMPLY WITH CERTAIN ADDITIONAL TERMS CONTAINED IN THE SERVICES PROVIDER USE RIGHTS ("SPUR") APPLICABLE TO Run IT Solutions Limited, WHICH TERMS MUST BE PROVIDED TO YOU BY Run IT Solutions Limited.

Microsoft does not permit you to use any Redistribution Software unless you expressly agree to and comply with such additional terms, as provided to you by Run IT Solutions Limited.
